2010 – 2011 Aspen Village Association Dues

Restrictions Violators Around the Neighborhood

The Board of Directors has adopted a policy & procedure for dealing with residents who violate the restrictions and covenants of Aspen Village Community Association. Each resident was mailed a copy with the annual dues notices. The restrictions state "No Parking Or Other Storage Of Trailers, Boat Trailers, Boats, And Trucks Shall Be Permitted On Any Lot In This Addition" There are several residents who have boats & trailers parked in the driveways or beside their house. It is an unwritten rule that has been around a long time that allows a resident forty-eight (48) hours to have a boat / trailer in the community. This intended to be in the spring & the fall for preparation for the season or preparation for storage. If you are a violator, be prepared for the new policies and procedure for dealing with violators. There are no exceptions. The restrictions are for everyone in the community to adhere to. The restrictions are designed to improve and maintain the aesthetics of Aspen Village.
